INVITATION FOR BIDS

For

Delivery of Primary Health Care Services under Partnership Agreement
(International Competitive Bidding for 23 Packages)

1. The Urban Primary Health Care Services Delivery Project-II (UPHCSDP-II), on behalf of LGD, now invites sealed bids from interested and eligible non-government organizations (NGOs), civil society organizations (CSOs), private entities, etc. for delivery of a defined package of primary health care services for a period of 5 (five) years based on the "Essential Services Delivery Plus" (ESD+) package and other defined objectives, standards and guidelines prescribed in the Bidding Documents in Dhaka South City Corporation, Dhaka North City Corporation, Rajshahi City Corporation, Khulna City Corporation, Barisal City Corporation, Sylhet City Corporation, Comilla City Corporation, Rangpur City Corporation, Narayanganj City Corporation, Gazipur City Corporation, Sirajgonj and Kishoregonj Municipality.
2. This Invitation for Bids follows the General Procurement Notice for this project that appeared in the "ADB Business Opportunities" on 7 November 2017. International Competitive Bidding (ICB) will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure and will be open to all bidders from ADB member countries.
3. The Government of the People's Republic of Bangladesh has applied for financing from the Asian Development Bank ("ADB") and from the Government of Sweden, towards the cost of the Urban Primary Health Care Services Delivery Project-II (UPHCSDP-II), under the Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives. LGD is the Executing Agency (EA) for the Project, and it intends to apply part of the proceeds of the loan and grants to payments under contracts for Partnership Area Agreements (PAAs) to provide specified primary health care services from 1 April 2018 to 31 March 2023.
4. Details of the scope of services, PAA, bidding procedures, eligibility of the bidder and other related information will be found in the bidding document available in the office of the undersigned. Bidding Documents may also be viewed on the following website: www.uphpc.gov.bd. Interested and eligible Bidders may obtain further information from the office of the undersigned and inspect the Bidding Documents from 9:00 am to 5:00 pm on any working day from 7 November 2017 to 6 January 2018.
5. The Bidding Documents in English language may be purchased by interested Bidders on submission of a written application to the address below and upon payment of a non-refundable fee of BDT 8,000.00 (Bangladesh Taka Eight Thousand) or US\$100 (One Hundred U.S. Dollars) for each set of Bidding Documents for each PAA. The payment will be made by Pay Order or Bank Draft in favor of the "Project Director, Urban Primary



Health Care Services Delivery Project" on behalf of the Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives. The documents may be sent by air mail or courier, or may be collected through authorized representatives. No liability will be accepted for loss or late delivery.

6. A Bidder may bid for one or more than one PAA but no more than five (5) PAAs. In such cases the Bidder shall have to submit separate Technical and Price Proposals and a Bid Security for each PAA for which a bid is submitted; otherwise the bids shall be rejected.
7. Bid(s) must be submitted to the office of the undersigned at the address below, on or before 7 January 2018 at 2:00 pm Bangladesh Standard Time. All Bids must be accompanied by a Bid Security in the amount indicated in the bidding document. Late bids shall be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below at 2:30 pm on 7 January 2018.
8. The undersigned will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
9. A pre-bid meeting will be held on 13 December 2017 at 10:00 am in the office of the undersigned. All prospective bidders are requested to attend.
10. The EA reserves the right to accept any bid and reject any or all bids without assigning any reason thereof.
